Maximum Fees and Charges under the Airport Fees Ordinance 1987, Guernsey Airport

All Airport fee rates are per metric ton or part thereof and are levied on all arriving and departing aircraft. All passenger charges are per movement, i.e. levied on all arriving and departing passengers. All charges are in £ Pounds Sterling.
