## Maximum Fees and Charges under the Airport Fees Ordinance 1987, Alderney Airport

All Airport fee rates, are per metric ton or part thereof and are levied on all arriving and departing aircraft. All passenger charges are per movement, i.e. levied on all arriving and departing passengers. Prices and payments are in £ Pounds Sterling.

<b>Fees For Aircraft Carrying Out Local Flights</b>	
<p><b>Airport Fees</b></p> <p>The fee payable for the arrival or departure of each aircraft which has taken off from Alderney Airport and returned to the Airport without having landed elsewhere.</p>	4.97
<p><b>Passenger Fees</b></p> <p>The fee for the arrival or departure of a passenger on an aircraft in passenger configuration which has taken off from Alderney Airport and returned to the Airport without having landed elsewhere.</p>	1.22
<b>Fees For Private Aircraft<sup>ii</sup></b>	
<p>Aircraft not exceeding five metric ton maximum permissible take-off weight:</p> <ul style="list-style-type: none"> <li>• The fee for the arrival or departure of a private aircraft, the last point of departure of which is, or the next point of arrival is 55 nautical miles or more from Alderney Airport.</li> </ul>	7.88

<b>Fees For Test, Familiarisation And Training Flights</b>	
<p><b>Airport Fees</b></p> <p>The fee payable for the arrival or departure of an aircraft which is being used solely for a test, familiarisation or training flight.</p>	4.56
<p><b>Runway Approach Fees<sup>iii</sup></b></p> <p>The fee payable for an aircraft on a test, familiarisation or training flight which approaches the runway for the purposes of making a simulated landing but does not land at the Airport.</p>	9.29
<p><b>Circuit Fees</b></p> <p>The fee payable for an aircraft on a test, familiarisation or training flight which completes a circuit.</p>	4.97
<b>Additional Fees For Availability Of Alderney Airport Outside Promulgated Hours</b>	
<p>An additional fee shall be payable for the use of Alderney Airport outside of the promulgated hours of operation for each movement of an aircraft.</p>

(ii) Medivac flights between 2101 hours and 2229 hours	729.73
(iii) Medivac flights between 2230 hours and 2259 hours	1,475.25
(iv) Medivac flights between 2300 hours and 2329 hours	1,777.46

<b>Aircraft Parking Fees</b>	
A parking fee shall be payable for parking at Alderney Airport of each aircraft after the expiration of the free period set out below from the time of the aircraft's arrival at the Airport.	<b>Free Period</b>
<ul style="list-style-type: none"> <li>• Private aircraft under 5 metric tons maximum permissible weight.</li> </ul>	72 hours
<ul style="list-style-type: none"> <li>• Private aircraft exceeding 5 metric tons maximum permissible weight.</li> </ul>	2 hours
<ul style="list-style-type: none"> <li>• Aircraft operated for hire and reward.</li> </ul>	2 hours
<p>The parking fee shall be calculated in respect of each period of 24 hours or part thereof after expiration of the free period appropriate to the aircraft concerned and before the time of take-off.</p> <ul style="list-style-type: none"> <li>• For the first metric ton.</li> </ul>	15.55
<ul style="list-style-type: none"> <li>• For each additional metric ton.</li> </ul>	3.24

<sup>ii</sup> Operators of private aircraft who do not make payment of fees and charges before departing from the Airport will be subject to a surcharge at the rate of 100% in respect of the fee for that aircraft.

<sup>iii</sup> This charge will continue as a single charge, as it cannot be split on a per movement basis

<sup>iv</sup> Additional costs for spill kits and waste disposal may apply.
