All Airport fee rates, are per metric ton or part thereof and are levied on all arriving and departing aircraft. All passenger charges are per movement, i.e. levied on all arriving and departing passengers. Prices and payments are in £ Pounds Sterling.

ii Operators of private aircraft who do not make payment of fees and charges before departing from the Airport will be subject to a surcharge at the rate of 100% in respect of the fee for that aircraft.

This charge will continue as a single charge, as it cannot be split on a per movement basis
